34 Arrested in Non-Support Warrant Sweep

The Somerset County Sheriff's Office recently conducted a non-support warrant sweep known as "Operation Cadbury" that resulted in 34 arrests.

"This successful roundup was conducted to remind parents of the importance of making regular child-support payments," said Sheriff Frank J. Provenzano. "Children depend on child support for their basic needs, including food, shelter and healthcare. 'Operation Cadbury' centered around the hope of renewing the parental commitment necessary for thriving children."

The operation involved more than 24 Sheriff's Officers, operating in teams, serving outstanding warrants and making arrests. A total of 34 men and women who owe more than \$699,800 were arrested.
